Call to Order & Minutes Approved

Deaka McClain called the meeting to order at 1:13 p.m. Deaka introduced the minutes of the August 16, 2014 meeting.

The minutes were unanimously approved by the committee members.

Regional Center Update

Elizabeth Stroh reported about the Integrated Health Project. The "Project" has developed 20 homes in an effort to get more people out of the Developmental Centers. We have a goal of placing 23 clients into the community from the Developmental Centers for this fiscal year. HRC currently has four clients already out and are working diligently on placing more in the community.

Elizabeth also shared that the Lanterman Developmental Center will be officially closed by the end of December 2014. Lanterman used to have over 3,000 people living there at one time and by the end of November there will only be one client left. The closure is a significant accomplishment for all the Regional Centers. Harbor Regional Center has stepped up and has provided many living and day program options for these clients coming out of the institutions. The initiative to close more Developmental Centers will continue.

Elizabeth shared that we recently had our Hope Fundraiser on 11/3/2014 at the Rolling Hills Country Club. This was the 7th Annual fundraiser and it was a huge success. HRC was able to raise a lot of money for HOPE which in turn will help clients have options of affordable housing in nice, safe neighborhoods. A few members from CAC shared that they are very thankful for the HOPE program and that it has provided them with the ability of living in a reasonably priced homes in a good areas.

Elizabeth also shared that there continues to be an employment initiative for the DDS population. Harbor Regional Center continues to work closely in collaboration with supported employment agencies in finding our clients jobs in the community making minimum wage or higher. \

Elizabeth briefly talked about Self Determination and encouraged members who are interested to contact their counselors. This is Senate Bill 468 and it has officially been signed into law. Only 98 people will start the Self Determination Pilot Program and these clients will have to meet certain criteria in order to be considered.

CAC Outreach

Deaka McClain and Kelly Sutton reported on the recent visit to SVS Lakewood Partial Work Day Program on October 30, 2014. Brent Fryhoff made arrangements, with Kelly Sutton's assistance, in coordinating the visit. The following CAC members were present at the visit: Kelly Sutton and Deaka McClain. CAC Members passed out information about the CAC group to clients at SVS Lakewood and talked about the Client Advisory Committee's role and purpose. The CAC group also toured SVS Lakewood. Deaka was able to share some of the challenges she has faced in her life to the clients of SVS Lakewood and how she was able to overcome these obstacles. There were a few SVS clients who were interested in what the Client Advisory Committee has to offer.

Brent Fryhoff shared to the CAC group that this type of day program was originally developed to give clients at the sheltered workshops other options of work. Clients at this Partial Work Program are able to earn minimum wage and work in places such as Home Goods, Walgreens, and H&H Nursery. They are able to gain "real life" work experience at businesses in the community up to 50% of the time while at program. This type of day program has become rather popular and all three programs of this model are currently full. Brent Fryhoff let CAC members know that an SVS Lakewood II will be opening sometime next year and will be able to accommodate 60 more clients once it is licensed.

CAC By-Laws

Brent Fryhoff distributed the finalized CAC By-Laws. The By-Laws were unanimously approved after three revisions.

Discussion of CAC Future Events

CAC members would like to have Harbor Regional Center's Benefits Specialist, Cori Reifman, come and talk about the recent changes with Medi-Cal and IHSS.

This continues to be CAC Member's first preference of a speaker. Cori was unable to attend this meeting; however is planning on attending the meeting in February at the Torrance office.

The committee members discussed the possibility of a health fair for adults in the fall of 2015. First round planning will focus on building a collaborative organizing group among the members of the Client Services and Client Advisory Committees with staff from the Adolescent and Adult Services.

Timelines were discussed with and the recommendation for the collaboration will be presented at the next CA meeting. A planning group will be identified and will target completing a final proposal by mid-February.

Initial ideas for the health fair include looking at the most recent results from the National Core Indicators (NCI) survey – focusing on preventative screenings for mammograms, prostate and pap smears.

DISCUSSION:

Restoration of Early Start - eligibility.

When the "at risk" criteria for eligibility as defined in the California Early Intervention Services Program (Early Start) was eliminated in 2009, many infants and toddlers in our service area were no longer eligible for service coordination and other services from HRC. However, the Family Resource Centers were provided with additional funding to create the Prevention/PRRS program. A total of 305 infants/toddlers and their families have been referred.

The HRC Family Resource and Assistive Technology Center has offered a wide array of supports and parent education opportunities. The program, called *Together From the Start (TFS)*, has provided many small group sessions for language, motor and social development. The focus is on strengthening families through information and support, utilizing instruction as well as parent-to-parent connections. Enrollment and attendance at sessions is high and feedback from participating families has been extremely positive.

As of January 1st the infants and toddlers who meet the "at risk" criteria will be eligible for Early Start program., and this will most likely included those being served in the Prevention/PRRS program. The Committee members discussed concerns about the continuation of the successful TFS classes, notification to PRRS families, and the potential need for additional Early Intervention Counselors due to the client/families moving to Early Start services as an increase in applicants for services once the community is knowledgeable about the eligibility changes.

Holiday Fund

The committee reviewed Holiday Funds raised in 2013 and thus far in 2014. Members were reminded that the funds raised in a given year will determine the amount of Holiday Fund expenditures in the following year.

Funds were raised in 2013 through a combination of grants and individual donations totaling just under \$25,000. This committee supports the recommendation to the Board that this amount be allocated for Holiday Fund expenditures in the 2014 season.

We have had an excellent start to our 2014 fundraising, still in progress in the current year.

Grants thus far this year from Boeing Employee Charity Fund, More Opportunities for Developmentally Disabled, and Del Harbor Foundation have totaled \$19,000. We are hopeful that activities still in progress will raise at least what was raised last year.

- Harbor Regional Center was selected by the South Bay Sunrise Rotary to be the top charity for
 The RAT Beach Charity Bike Tour, taking place Sept 27. We will learn what the proceeds will be
 for the Harbor Help Fund later this year. (Proceeds for Harbor Help Fund were \$4500 from 2013
 event).
- We are now preparing for our annual direct mail fundraising campaign for the Holiday Fund (which in 2013 raised \$11,696).
- Nancy asked committee members to share information about the Holidays Are for Sharing program with potential donors and Adopt a Family sponsors.

Other Initiatives

During the spring we received sponsorships totaling \$39,000 which offset costs for recent 40th Anniversary Celebrations.

Nancy shared information about an upcoming HRC initiative for prevention of developmental disabilities. We are beginning the planning process together with the Board Planning Committee. There will be some events for which sponsorships will be sought. Members expressed interest in participating in these initiatives.

John suggested a future sponsored event could be targeted to parents and caregivers, such as a parents' night out at the Comedy and Magic Club.

HRC Performance Plan 2015

Public Input included the following comments:

We are so, so appreciative of the generous support of the HRC that has enabled him to participate in the program. It is apparent that HRC is working hard to support and strengthen the transition of clients from high school to college/work/post-school adulthood. My son has certainly benefitted from this effort! . A simple publication with short descriptions of C2C, HOPE, SSI,,,,etc (options and supports for adults) would have been enormously useful in helping me figure out where to get started and what I needed to do.

The HRC shows admirable improvement and an impressive above-the-state-average number of clients living in homes within the community... Clients living in homes is a good thing, if they are receiving the necessary supports.

The Performance Plan was presented at a public meeting, and approved by the HRC Board of Trustees, on September 16, 2014.

On November 3, 2014, it was approved by the Department of Developmental Services.




